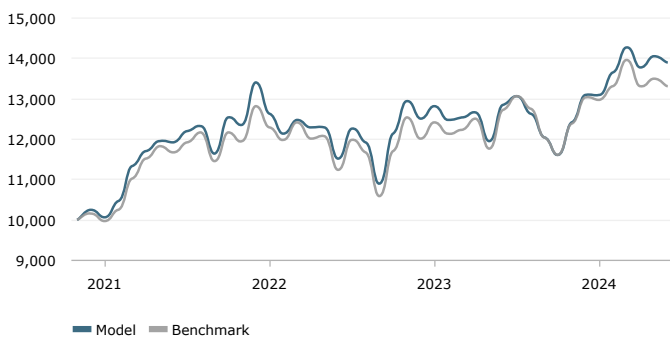


## INVESTMENT OBJECTIVE & STRATEGY

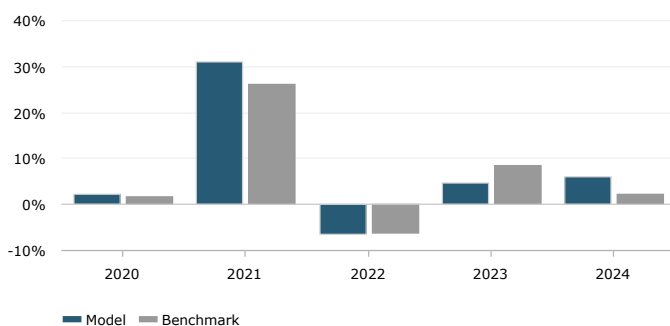
Astoria's Dividend Growers Stock Portfolio uses a quantitative and systematic approach.

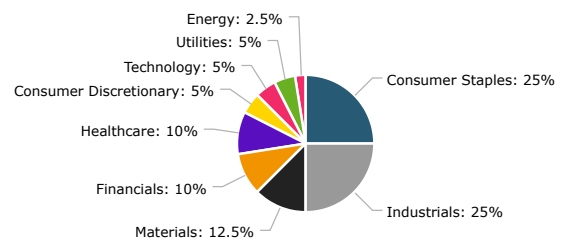
