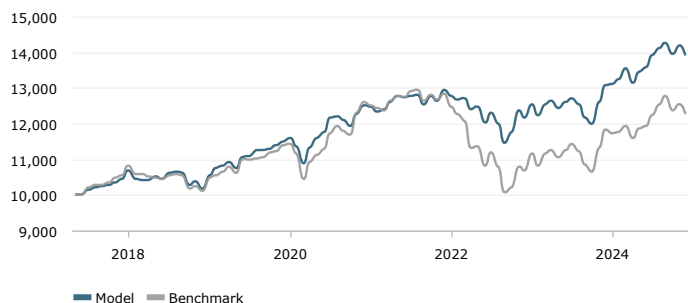
INVESTMENT OBJECTIVE & STRATEGY

Astoria's Dynamic 30/70 Strategy focuses on long term income and growth by blending various equity factors along with allocations to fixed income and alternatives.

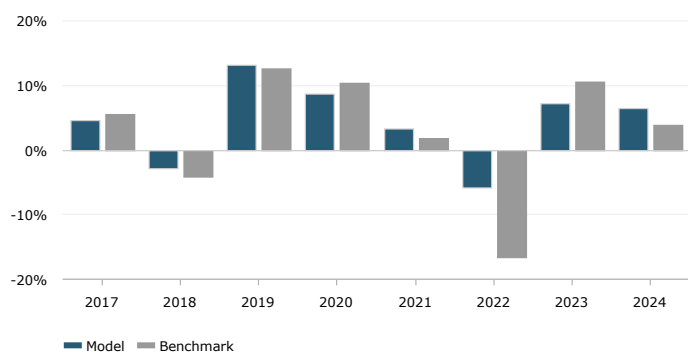
It will maintain approximately 25%-35% in equities, 50%-60% in fixed income, and 10%-15% in alternatives. Our benchmark is 30% MSCI All Country World Index (NDUEACWF) and 70% Bloomberg Barclays Global Aggregate Bond Index (LEGATRUU) and is rebalanced monthly.

There is generally one or two strategic rebalances per year assuming normal market conditions.

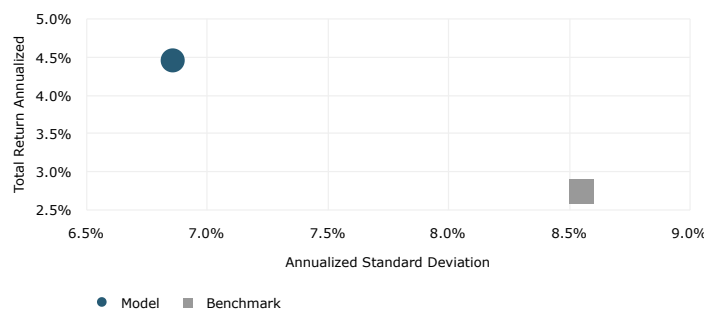

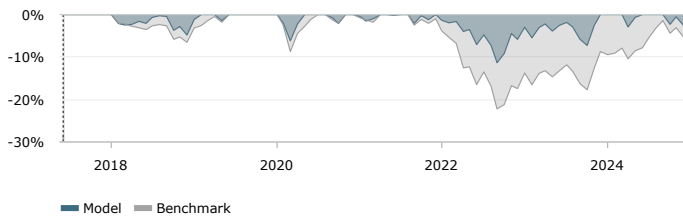

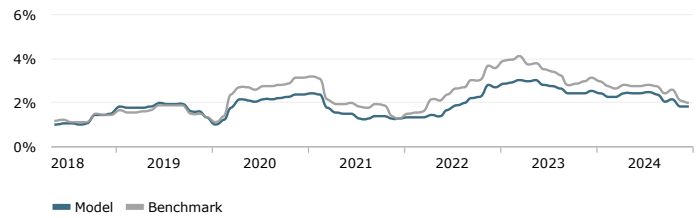
RISK/RETURN COMPARISON
