
INVESTMENT OBJECTIVE & STRATEGY

Astoria's Dynamic 60/40 Strategy focuses on long term growth by blending various equity factors along with allocations to fixed income and alternatives.


It will maintain approximately 60%-70% in equities, 15%-25% in fixed income, and 10%-15% in alternatives. Our benchmark is 60% MSCI All Country World Index (NDUEACWF) and 40% Bloomberg Barclays Global Aggregate Bond Index (LEGATRUU) and is rebalanced monthly.

There is generally one or two strategic rebalances per year assuming normal market conditions.





RISK/RETURN COMPARISON


