
### **INVESTMENT OBJECTIVE & STRATEGY**

Astoria's Dynamic 15/85 Strategy focuses on building reliable income by blending various fixed income instruments along with a modest allocation towards equities and alternatives.

It will maintain approximately 10%-20% in equities, 75%-85% in fixed income, and 3%-10% in alternatives. Our benchmark is 15% MSCI All Country World Index (NDUEACWF) and 85% Bloomberg Barclays Global Aggregate Bond Index (LEGATRUU) and is rebalanced monthly.

There is generally one or two strategic rebalances per year assuming normal market conditions.






