

Dynamic 70/30 ETF Portfolio



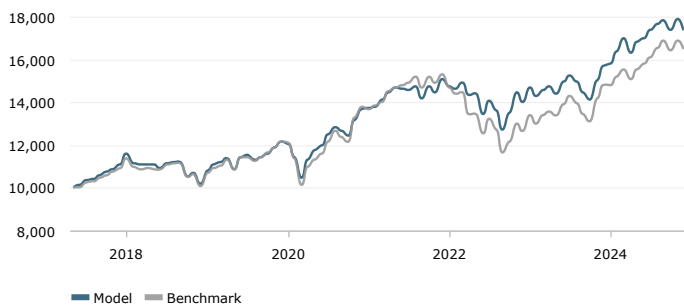
INVESTMENT OBJECTIVE & STRATEGY

Astoria's Dynamic 70/30 Strategy focuses on long term growth by blending various equity factors along with allocations to fixed income and alternatives.

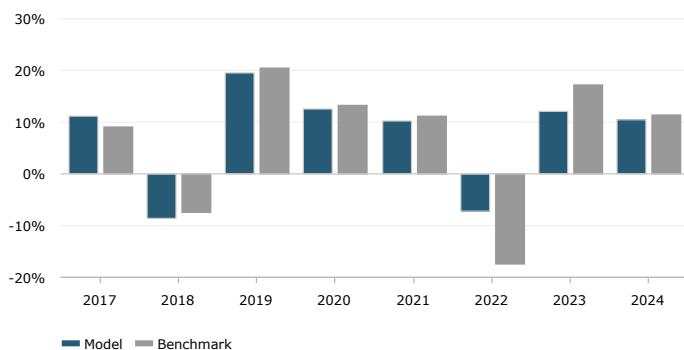
It will maintain approximately 70%-80% in equities, 10%-15% in fixed income, and 10%-15% in alternatives. Our benchmark is 70% MSCI All Country World Index (NDUEACWF) and 30% Bloomberg Barclays Global Aggregate Bond Index (LEGATRUU) and is rebalanced monthly.

There is generally one or two strategic rebalances per year assuming normal market conditions.

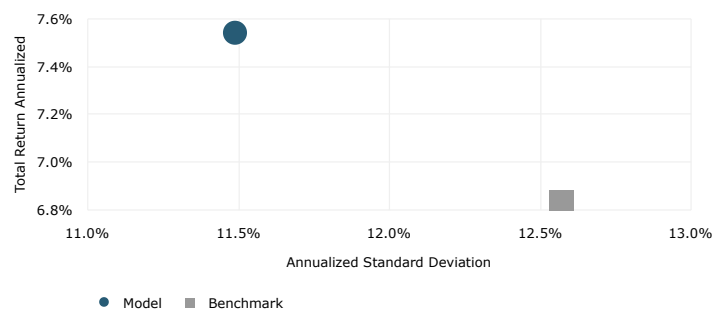

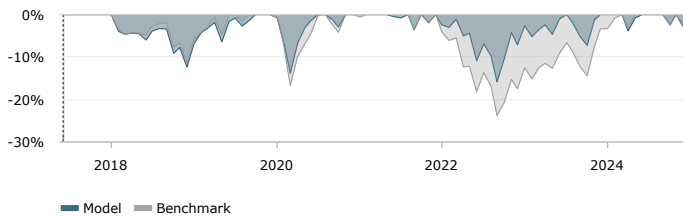

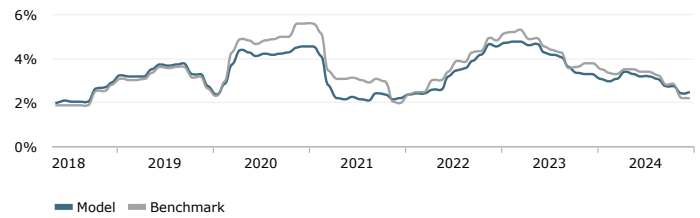
RISK/RETURN COMPARISON

Benchmark: The Dynamic 70/30 Model performance results shown are compared to the performance of 70% MSCI All Country World Index (NDUEACWF) and 30% Bloomberg Barclays Global Aggregate Bond Index (LEGATRUU). Prior to January 2021, the benchmark was 70% MSCI All Country World Index (NDUEACWF), 15% Bloomberg Barclays Global Aggregate Bond Index (LEGATRUU), and 15% Wilshire Liquid Alternative Multi-Strategy Index (WLIQAMST). The index results do not reflect fees and expenses and you typically cannot invest in an index. Return Comparison: Both the MSCI All Country World Index and the Bloomberg Global Aggregate Bond indices were chosen as they are generally well recognized as an indicator or representation of the stock and bond market and include a cross section of holdings.
